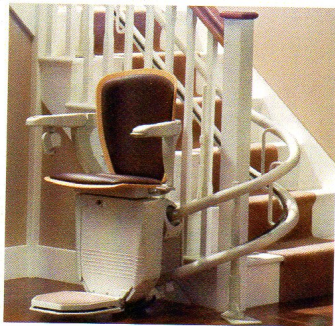

WPMPA MEETING 10/24/20 MINUTES - Updated

Meeting called to order at 10:00a by President John Flood

Treasurer's report by Dave Miller: Checking Account Total \$5,589.05; Savings Account Total 6,681.97 for Combined bank account totals as of 12,270.99; Club is on target for budgeted amount for the year. Motion made and passed to accept.

Nominations for next year's board were open and John Flood Appointed Tony Evans to fill Tom Jacobs position as he is no longer a paying member.

Nomination for Vic Tyber as Secretary was submitted and approved to fill Paris Whiley's position. It was unopposed. John Flood then appointed Vic to the position

Runway Approval Report by Dave Miller: Initially concept plan submitted was rejected and a follow up conversation and a follow up email was sent to make sure it was understood that it was not our intention to dig up the ground to put the runway in; this was the reason given for the rejection, that when we eventually leave we would leave the property 'not in its original condition'. Dave indicated that he received somewhat favorable new response saying it was being looked at from a different approach and that someone would be out to the field in the next few days (not including weekend) to take a look.

Discussion: Tony Evans indicated that we should have a commitment from them as to what date and time they would do this and Dave indicated that he had already asked them to let us know when that that might be so we could be there to have a discussion; but countered Tony's point that although it is desirable, we have no authority to tell them what to do or when.

Motion was made by Tony Evans to establish a committee to develop detailed plans, including material and cost, for the new 'runway covering' with the assumption that County Utilities Department approval is obtained; so it would be ready for a vote to proceed at the next WPMPA meeting and also to be available to present to the county if asked. The committee would consist of Dave Miller, Tony Evans, and Vic Tyber. Motion was passed. Tony engaged in a discussion about his feeling for the need for this and Dave read to the group his last correspondence discussing the issue with 'Utilities'.

Motion to accept Dave's report was also passed.

Motion to adjourn at 10:35 2nd and Passed and meeting was adjourned.
